A BASIN PLAN AMENDMENT TO MODIFY BENEFICIAL USES OF  
AND ESTABLISH WATER QUALITY OBJECTIVES FOR MERCURY  
IN SULPHUR CREEK

The Regional Water Quality Control Board, Central Valley Region (Water Board) will hold a public hearing to consider adoption of the proposed amendments to the Water Quality Control Plan for the Sacramento and San Joaquin River Basins (Basin Plan) that would determine that certain beneficial uses are not applicable and establish water quality objectives for mercury in Sulphur Creek (Colusa County), a tributary to Bear Creek in the Cache Creek watershed. As part of amending the Basin Plan, the Water Board will consider certification of the draft environmental documents prepared pursuant to Section 21080.5 of the Public Resources Code and Title 23 California Code of Regulations sections 3775-3782. After hearing testimony, the Water Board may choose to act on the proposed amendment or the Water Board may choose to close the hearings and vote on the proposed amendment at a subsequent meeting. The public hearing, to be conducted during the December 2006 Water Board meeting, is scheduled at the time and location noted below:

Draft environmental documents, which conclude no adverse impact to the environment, have been prepared for the proposed amendments. In order to be included in the written response to comments that is a part of the final administrative record, written comments should be submitted by 22 November 2006 to Karen Larsen, Regional Water Quality Control Board, Central Valley Region, 11020 Sun Center Drive, #200, Rancho Cordova, CA 95670. At the hearing on 7/8 December 2006 staff will summarize the written comments and present a final recommendation for Water Board consideration. Interested persons will be provided the opportunity to present oral comments to the Water Board at the hearing, and are expected to orally summarize their written submittals. Oral testimony will be limited in time by the Water Board Chair.
