CITY OF ANGELS WASTEWATER TREATMENT PLANT

CALAVERAS COUNTY

The City of Angels (Discharger) owns and operates the City of Angels Wastewater Treatment Plant. The Discharger applied for a National Pollutant Discharge Elimination System (NPDES) permit authorization to discharge tertiary treated effluent from City of Angels Wastewater Treatment Plant. The proposed NPDES permit allows a discharge up to 1.9 million gallon per day of UV disinfected tertiary treated effluent to Angels Creek. The proposed discharge is allowed to occur only during wet months when Angels Creek provides a flow ratio greater than or equal to 20:1 (Angels Creek to effluent). The tentative Waste Discharge Requirements (WDRs) include effluent limitations to ensure the protection of the beneficial uses of Angels Creek.

The designated parties for this hearing are as follows:

- Staff of Central Valley Regional Water Board
- City of Angels

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Board no later than **20 April 2007**. The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

The tentative Waste Discharge Requirements were issued on **6 March 2007**. Persons wishing to comment on this noticed hearing item shall submit testimony, evidence, if any, and/or comments in writing to the Regional Water Board no later than **6 April 2007**.

Written evidence or comments submitted after **6 April 2007** will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

All designated parties and interested persons may speak at the Regional Water Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair
