**PUBLIC HEARING**

TENTATIVE REVISED WASTE DISCHARGE REQUIREMENTS  
FOR  
WESTERN PLACER WASTE MANAGEMENT AUTHORITY  
FOR  
CONSTRUCTION AND OPERATION  
WESTERN REGIONAL SANITARY LANDFILL FACILITY  
CLASS II AND CLASS III LANDFILLS  
PLACER COUNTY

Western Placer Waste Management Authority (WPWMA) owns the Western Regional Sanitary Landfill Facility, a municipal solid waste landfill about five miles north-northeast of Roseville. WPWMA has requested that the Regional Water Board approve changes to the landfill and liner system design that are currently found in Waste Discharge Requirements (WDRs) Order No. R5-2002-0218. The proposed changes include:

1. Decreasing the thickness of the leachate collection and removal system (LCRS) gravel drainage layer from 12 inches to 9 inches.
2. Increasing the steepness of the interior side-slope of the excavation for the landfill from a ratio of 3H:1V to a ratio of 2H:1V.
3. Eliminating the geocomposite drainage layer LCRS on the 2H:1V interior side-slope.

Additional information about the proposed changes can be found in the Findings of the tentative WDRs and in the Information Sheet.

The designated parties for this hearing are as follows:

- Staff of Central Valley Regional Water Board
- Discharger – Western Placer Waste Management Authority

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Board no later than **12 April 2007**. The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

Persons wishing to comment on this noticed hearing item shall submit testimony, evidence, if any, and/or comments in writing to the Regional Water Board no later than **12 April 2007**. Written evidence or comments submitted after **12 April 2007** will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

All designated parties and interested persons may speak at the Regional Water Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair
