NPDES PERMIT NO. CA0079197

**CITY OF ATWATER
WASTEWATER TREATMENT FACILITY
MERCED COUNTY**

The City of Atwater owns and operates a wastewater collection, treatment, and disposal system (WWTF) to provide municipal sewerage service to the City of Atwater (population 25,700), Castle Aviation and Development Center, and the unincorporated community of Winton (population 11,000). The WWTF discharges disinfected secondary-treated wastewater under a National Pollutant Discharge Elimination System (NPDES) permit to the Atwater Drain, a water of the United States. Veolia Water North America – West, LLC operates the WWTF. On 7 December 2006, the Central Valley Regional Water Quality Control Board (Regional Water Board) considered renewal of NPDES Permit No. CA0079197 to authorize continued discharge to the Atwater Drain from the City's wastewater treatment facility. The Regional Water Board continued the hearing to reconsider limitations and monitoring for ammonia. However, as over six months have elapsed, it may wish to reconsider time schedule due dates.

A public hearing concerning ammonia issues, and subject to Regional Water Board discretion possible time schedule revisions, will be held during the Regional Water Board meeting scheduled for:

At the conclusion of the hearing, the Regional Water Board may adopt the permit. The designated parties for this hearing are as follows:

- Staff of Regional Water Board
- City of Atwater
- California Sportfishing Protection Alliance

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Board no later than **15 May 2007**. The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

Persons wishing to comment on this noticed hearing item must submit such comments in writing to the Regional Water Board no later than **15 May 2007**. Written testimony or comments submitted after **15 May 2007** will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

All designated parties and interested persons may speak at the Regional Water Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair.
