The CalMat Co., Walter A. and Elizabeth A. Baun, and Darrell D. and Janet Delevan (collectively Discharger) own and operate the Sanger Sand and Gravel Plant at 17041 East Kings Canyon Road in Sanger, California. Process wastewater and groundwater is discharged to the Kings River, a water of the United States. The Regional Water Board will consider renewal of NPDES Permit No. CA0078174 to authorize continued discharge. The Permit will be considered at a public hearing concerning this matter during its meeting scheduled for:

Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Regional Water Board no later than **24 April 2007**. The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

Persons wishing to comment on this noticed hearing item must submit such comments in writing to the Regional Water Board no later than **24 April 2007**. Written testimony or

comments submitted after **24 April 2007** will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.


