**PUBLIC HEARING**

**WASTEWATER TREATMENT PLANT**  
**YOLO COUNTY**

The City of Davis (Discharger) owns and operates a municipal Wastewater Treatment Plant that serves the City of Davis, excluding the University of California Davis Campus. Both the existing and tentative NPDES permits allow up to 7.5 million gallons per day (mgd) of treated wastewater to be discharged to the Willow Slough Bypass and Conaway Ranch Toe Drain, a tributary to the Yolo Bypass. The tentative NPDES permit renewal of existing Order No. 5-01-067 proposes a significant number of new effluent limitations.

A public hearing concerning the tentative NPDES permit will be held during the Central Valley Regional Water Quality Control Board (Regional Water Board) meeting scheduled for:

The designated parties for this hearing are as follows:

Only designated parties will have the right to (1) call and examine witnesses, (2) introduce exhibits, (3) cross-examine opposing witnesses, (4) impeach any witness, and/or (5) rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Regional Water Board no later than **25 May 2007**. The request must explain the basis for status as a designated party and, in particular, how the person is directly affected by the discharge.

Persons wishing to comment on this noticed hearing item and/or the tentative NPDES permit must submit testimony, evidence, and/or comments in writing to the Regional Water Board no later than **22 May 2007**. Written evidence or comments

submitted after **22 May 2007** will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

All designated parties and interested persons may speak at the Regional Water Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair.
