**NOTICE**  
**TENTATIVE REVISED WASTE DISCHARGE REQUIREMENTS**  
**FOR**  
**CLEAN CLOSURE OF**  
**FOLSOM CORPORATION YARD LANDFILL**  
**CITY OF FOLSOM**  
**CLASS III LANDFILL**  
**SACRAMENTO COUNTY**

**TO ALL CONCERNED PERSONS AND AGENCIES:**

The Regional Water Quality Control Board, Central Valley Region will consider adopting revised waste discharge requirements (WDRs) for the Folsom Corporation Yard Landfill at its meeting on **31 July/1 August 2008**. The proposed WDRs prescribe requirements for the Discharger's plan to clean close (i.e., excavate and remove) the landfill. The landfill was previously closed with a low permeability clay cover in 1996 to comply with Title 27 regulations. Clean closure is intended as a corrective action measure to address shallow groundwater impacts from the landfill consisting of elevated inorganic salts and dissolved metals. The WDRs prescribe requirements for various project operations such as waste excavation, characterization, disposal, and confirmation sampling. The WDRs also require that the Discharger obtain coverage under the general storm water permit and provide updated cost estimates and funding for corrective action financial assurances in approved amounts. The monitoring and reporting program in the WDRs requires semiannual groundwater monitoring for most landfill monitoring parameters, and specifies the criteria for demonstrating groundwater cleanup under Title 27.


