NOTICE OF PUBLIC HEARING and NOTICE OF FILING OF DRAFT ENVIRONMENTAL DOCUMENTS Concerning

Amendments to the Water Quality Control Plan for the Sacramento River and San Joaquin River Basins (the "Basin Plan") for the Control of Diazinon and Chlorpyrifos

The Central Valley Regional Water Quality Control Board (Central Valley Water Board or Board) is developing a program to regulate discharges of the pesticides chlorpyrifos and diazinon into selected surface waters. The Board is proposing amendments to the Basin Plan that would incorporate this program into the Basin Plan. The Board has previously invited the public to comment on this proposal. However, in response to input from the public, Board staff have made numerous changes to the proposed Basin Plan Amendment. The Board is seeking additional public input and is therefore releasing a revised draft of the Basin Plan Amendment and Substitute Environmental Documentation for additional comment.

The regulatory program includes:

- New numeric diazinon and chlorpyrifos water quality objectives for water bodies throughout the Sacramento and San Joaquin River Basins, below the major dams.
- Implementation and monitoring requirements to ensure the proposed objectives are attained.
- Specific implementation requirements to address diazinon and chlorpyrifos water quality impairments in 31 water bodies which have been placed on the Clean Water Act Section 303(d) list due to diazinon and/or chlorpyrifos impairments
- Policies and monitoring programs that address alternative pesticides to diazinon and chlorpyrifos.

The Board's Basin Planning Program is considered a certified regulatory program, which means that the Board is exempt from the requirement to prepare an environmental impact report for basin planning activities under the California Environmental Quality Act because a sufficiently rigorous environmental review is incorporated into the basin planning process itself. (Pub. Res. Code, § 21080.5.; Cal. Code Regs., tit. 14, § 15251(g).) The Board's environmental review of the proposed Basin Plan Amendments is contained in a draft Staff Report, which is considered to be "substitute environmental documentation" or "SED", and which is posted on the Board's website (below):

The Board is inviting the public and other agencies to submit written comments on the proposed Basin Plan Amendments and draft SED from **3 January 2014** through **18 February 2014**. Written comments must be submitted to the above email or postal address by this deadline in order for them to be included in the administrative record.


The Central Valley Water Board has scheduled a hearing on the following dates to receive oral comments and consider taking action on the proposed Basin Plan Amendments and draft SED:

At the hearing, Board staff will provide the Board with recommendations regarding the proposed Basin Plan Amendments and draft SED. At the hearing, the Board will also provide another opportunity for members of the public and representatives of other agencies to provide oral comments regarding the proposed Basin Plan Amendments and the adequacy of the draft SED. Speakers are expected to orally summarize their written submittals. At the March hearing, the Board may adopt the Basin Plan Amendments and SED as proposed, or it may adopt them with changes that are consistent with the general purpose of the proposed amendments, or it may continue consideration of the matters to a subsequent Board meeting.

Oral testimony will be limited in time by the Board Chair. Groups are encouraged to designate a spokesperson. All exhibits presented at the hearings, including charts, graphs, and other testimony, must be left with the Board and will become part of the administrative record. The meeting facilities will be accessible to persons with disabilities.
