ADMINISTRATIVE CIVIL LIABILITY COMPLAINT NO. R5-2014-0523 FOR FAILING TO COMPLY WITH WATER CODE SECTION 13267 ORDER, JASWINDER SHERGILL AND HARDIP SINGH SANDHU, PAYLESS FOOD & GAS MART, REDDING, SHASTA COUNTY

Enclosed is an Administrative Civil Liability Complaint (Complaint), issued pursuant to California Water Code Section 13268 (b), for failing to furnish technical or monitoring reports as required by a California Water Code Section 13267 Order Issued on 21 December 2012. The Complaint charges Jaswinder Shergill and Hardip Singh Sandhu with administrative civil liability in the amount of **forty three thousand six hundred dollars (\$43,600)**, which represents violations accrued 18 January 2013 through 12 May 2014.

Pursuant to California Water Code section 13323, Jaswinder Shergill and Hardip Singh Sandhu may either pay the proposed administrative civil liability and waive their right to a hearing before the Regional Water Board, or may contest the Complaint and exercise their right to a hearing. Jaswinder Shergill and Hardip Singh Sandhu have the right to a hearing before the Regional Water Board within 90 days of the service of the Complaint. If Jaswinder Shergill and Hardip Singh Sandhu choose to waive this right and settle the Complaint without a hearing, then a duly authorized agent must sign the enclosed waiver and submit it to this office by **11 June 2014**. The Complaint will be considered settled pending a 30-day period, tolled from the date of this Complaint, during which time interested parties may comment on this action by submitting information to this office, attention Melissa Buciak.

If the Regional Water Board does not receive a waiver and payment for the full amount by **11 June 2014**, then a hearing will be scheduled for the **7/8 August 2014** Central Valley Water Board meeting in Rancho Cordova. Specific notice about this hearing and its procedures will be provided under separate cover.

Any comments or evidence concerning the enclosed Complaint must be submitted to this office, attention Melissa Buciak, so that they are received no later than **5 p.m. on 11 June 2014**. This includes material submitted by Jaswinder Shergill and Hardip Singh Sandhu to be considered at a hearing and material submitted by interested parties, including members of the public, who wish to comment on the proposed settlement. If the Central Valley Water Board does not hold a hearing on the matter, and the terms of the final settlement are not significantly different from those proposed in the enclosed Complaint, then there will not be additional opportunities for public comment on the proposed settlement. Written materials received after **5 p.m. on 11 June 2014** will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.
