NOTICE OF PUBLIC HEARING

**RENEWAL OF WASTE DISCHARGE REQUIREMENTS
(NPDES NO. CA0079464)
FOR
SAN ANDREAS SANITARY DISTRICT
WASTEWATER TREATMENT PLANT
CALAVERAS COUNTY**

San Andreas Sanitary District is the owner and operator of the San Andreas Sanitary District Wastewater Treatment Plant (Facility), a publicly owned treatment works located at 675 Gold Oak Road, San Andreas, CA. The Facility provides sewerage services for the town of San Andreas, serving a population of approximately 2200. Waste Discharge Requirements Order R5-2009-0007 (NPDES No. CA0079464) regulates discharges from the Facility. Treated wastewater is stored on-site and is disposed via spray irrigation to land within the property boundaries of the Facility during the dry season. Due to insufficient storage capacity to contain all wastewater during the wet season, seasonal discharges are authorized from 1 November through 30 April of 1.5 million gallons per day (MGD) of treated effluent to the North Fork Calaveras River, a water of the United States.

The proposed NPDES permit renewal includes new or revised effluent limitations for ammonia (as N) and cyanide. In addition, the effluent limits for bis(2-ethylhexyl)phthalate, chlordane, copper, chronic toxicity, diazinon, iron, settleable solids, and zinc have been removed because the discharge does not have reasonable potential to cause or contribute to an exceedance of the applicable water quality objectives for these constituents.

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Central Valley Water Board no later than **5:00 p.m. on 30 June 2014**. The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

Persons wishing to comment on this noticed hearing item shall submit testimony, evidence, if any, and/or comments in writing to the Central Valley Water Board no later than **5:00 p.m. on 30 June 2014**. Written evidence or comments submitted after **5:00 p.m. on 30 June 2014** will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

All designated parties and interested persons may speak at the Central Valley Water Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair.
