NOTICE OF BOARD INFORMATION ITEM

**MONITORING AND DATA COLLECTION NEEDS AND CHALLENGES FOR
PYRETHROID PESTICIDES**

**CENTRAL VALLEY PYRETHROID PESTICIDES TMDL
AND BASIN PLAN AMENDMENT**

NOTICE IS HEREBY GIVEN that the California Regional Water Quality Control Board, Central Valley Region (Central Valley Water Board) will hold an information item regarding monitoring and data collection needs and challenges related to pyrethroid pesticides. The information item will include discussion of chemical analysis for pyrethroid pesticides and toxicity testing with the amphipod *Hyalella azteca*. Information about monitoring for these parameters will help support the development of amendments to the Water Quality Control Plan for the Sacramento River and San Joaquin River Basins (the "Basin Plan") for the control of discharges of pyrethroid pesticides.

The Central Valley Water Board has scheduled to include the information item at the Board's meeting that will be held at the following date and location:

At the June information item, Board staff and other technical experts will provide the Board with information regarding chemical analysis for pyrethroid pesticides and water column toxicity testing using the test organism *Hyalella azteca*. The Board will provide members of the public and representatives of other agencies the opportunity to present oral comments regarding monitoring and data collection for pyrethroid pesticides. Though the Board may provide direction to Board staff, the Board will not take action on this topic at the June meeting. Oral comments will be limited in time by the Board Chair. Groups are encouraged to designate a spokesperson.
