TO ALL CONCERNED PERSONS AND AGENCIES:

Enclosed is a tentative Waste Discharge Requirements Order for City of Shasta Lake (Discharger), Wastewater Treatment Facility (Facility). Any comments or recommendations you may have concerning the proposed Order should be submitted to this office no later than 5:00 p.m. on **13 November 2020** in order for us to give them full consideration prior to the meeting of the Central Valley Regional Water Quality Control Board (Central Valley Water Board). Written material submitted after 5:00 p.m. on **13 November 2020** will not be accepted and will not be incorporated into the administrative record absent a ruling by the Board Chair. Any party requesting to submit late materials must demonstrate good cause for the late submission, and the Chair must find that accepting the late submission will not prejudice the Central Valley Water Board or any Designated Party.

A Public Hearing has been scheduled for the Central Valley Water Board to consider adoption of the proposed Orders at its **10/11 December 2020** Board Meeting. A Notice of Public Hearing (Notice) concerning the proposed Orders is also enclosed. Regulations require the Discharger post one (1) copy of the Notice at the nearest city hall or county courthouse, one (1) copy at the post office nearest to the Facility (if

allowed), and one (1) copy at the public entrance to the Facility. Please post and publish the Notice as soon as possible and provide proof of posting and publication by **10/11 December 2020**. Use the enclosed form for proof of posting. Proof of publication shall consist of an affidavit from the newspaper along with a copy of the published notice.

To conserve resources, this letter transmits a paper copy of the tentative NPDES Permit package to the Discharger only.
