The City of Manteca is the owner and operator of the Wastewater Quality Control Facility (Facility), a publicly owned treatment works located at 1001 West Center Street, Manteca, California. The Facility provides sewerage services for the City of Manteca and portions of the City of Lathrop, serving a population of approximately 97,000. The Facility provides tertiary treatment for up to an average dry weather flow of 9.87 million gallons per day (MGD). Tertiary-treated wastewater from the Facility is discharged to the San Joaquin River, within the Sacramento-San Joaquin Delta, a water of the United States.

Discharges from the Facility are currently regulated by Waste Discharge Requirements Order R5-2015-0026, issued by the Central Valley Regional Water Quality Control Board (Central Valley Water Board) on 17 April 2015. An Order is proposed to renew the NPDES permit. The proposed permit includes new or updated effluent limitations for biochemical oxygen demand, total suspended solids, pH, and ammonia (as nitrogen).

The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.
