NOTICE OF PUBLIC HEARING
concerning

TENTATIVE REVISED WASTE DISCHARGE REQUIREMENTS
FOR
STANISLAUS COUNTY DEPARTMENT OF ENVIRONMENTAL RESOURCES
FINK ROAD LANDFILL
CLASS II AND CLASS III LANDFILL
CONSTRUCTION, OPERATIONS, CLOSURE, POST-CLOSURE MAINTENANCE,
AND CORRECTIVE ACTION
STANISLAUS COUNTY

Revised waste discharge requirements (WDRs) are tentatively being issued to Stanislaus County Department of Environmental Resources as the operator and landowner, also known as the discharger (Discharger) for the Fink Road Landfill (Facility) located at 4000 Fink Road, Crows Landing, in Stanislaus County near the Interstate 5 freeway about six miles south of the City of Patterson and 4.5 miles west of the town of Crows Landing.

Fink Road Landfill is an existing active 203-acre municipal solid waste (MSW) landfill facility. This revised Order continues to prescribe waste discharge requirements for construction, operation, monitoring, corrective action, closure, and/or postclosure maintenance of three classified landfill units and two classified surface impoundment units under Title 27 regulations. The revised Order includes amongst other things prohibitions, specifications, and provisions for (a) Construction of three additional landfill modules (LF-2 Cells 5 & 6 and LF-3 Cell 4); (b) Plans for infill and vertical expansion of LF-2 that would extend the estimated active life of the Facility by 27 years; (c) An updated Preliminary Closure and Postclosure Maintenance Plan for landfill closure after lateral and vertical expansion of LF-2; (d) An updated slope stability analysis and pipe hydraulics and loading calculations for the proposed infill and vertical expansion of LF-2; and (e) An updated Water Quality Protection Standards Report.

Only designated parties will have these rights: to call and examine witnesses; to introduce exhibits; to cross-examine opposing witnesses; to impeach any witness; and to rebut the evidence against him or her. All other persons wishing to testify or provide comments are interested persons and not designated parties. Such interested persons may request status as a designated party for purposes of this hearing by submitting such request in writing to the Central Valley Water Board no later than **5:00 p.m. on 30 June 2021**. The request must explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

The Tentative Permit was issued for a 30-day public comment period on **28 May 2021** and comments are due by **5:00 p.m. on 30 June 2021**. Written evidence or comments submitted after **5:00 p.m. on 30 June 2021** will not be accepted and will not be incorporated into the administrative record absent a ruling by the Board Chair. Any person requesting to submit late materials must demonstrate good cause for the late submission, and the Chair must find that accepting the late submission will not prejudice the Central Valley Water Board or any Designated Party.

All designated parties and interested persons may speak at the Central Valley Water Board meeting and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair.
