RESCINDING WASTE DISCHARGE REQUIREMENTS

The California Regional Water Quality Control Board, Central Valley Region (Central Valley Water Board), finds that the Central Valley Water Board adopted the following Orders which are no longer applicable for the reasons shown:

A. BOB FERGUSON INDEPENDENT; ASPHALTO OIL FIELD; WASTE DISCHARGE REQUIREMENTS ORDER NO. R5-2004-0056; KERN COUNTY

Waste Discharge Requirements (WDRs) Order R5-2004-0056, adopted on 23 April 2004 and issued to Bob Ferguson Independent, regulates the discharge of produced water to four unlined surface impoundments (ponds) on the Government Ferguson Lease in the Asphalto Oil Field. From 2020 through 2022, Central Valley Water Board staff worked with Bob Ferguson Independent to finalize the closure of the ponds and petroleum facility. As of today, oil impacted soil from the ponds and facility has been removed and transported to a third-party permitted disposal facility, ponds are backfilled to natural grade, the petroleum production facility was dismantled and hauled off-site for disposal, and the entire footprint of the facility was re-seeded with natural vegetation. Therefore, it is appropriate to rescind Waste Discharge Requirements Order R5-2004-0056.

B. SHASTA MARINA AT PACKERS BAY; ORDER R5-2007-0150; SHASTA COUNTY

Waste Discharge Requirements Order R5-2007-0150, adopted on 2 August 2007, prescribes requirements for waste discharge from Packers Bay Marina, Holiday Flotels, Inc. (Discharger) wastewater treatment facilities (Facility). The Discharger previously discharged wastewater to an onsite leach field. The Discharger ceased wastewater discharge from the Facility in 2014 prior to selling the Facility to Harkrader Trucking, Inc. DBA Shasta Marina at Packers Bay (Shasta Marina) which started operations at the site in 2016. Shasta Marina has never discharged wastewater to the onsite leach fields at the Packers Bay location and has since removed the facility's septic tanks and leach field infrastructure. Shasta Marina requested rescission of the permit. Therefore, it is appropriate to rescind Waste Discharge Requirements Order R5-2007-0150.

IT IS HEREBY ORDERED that the above Orders are rescinded on the date of this order unless otherwise stated above.
