WASTE DISCHARGE REQUIREMENTS ORDER R5 2023-#### VULCAN MATERIALS COMPANY CARLI EXPANSION SITE – PHASE T-2 PROJECT SACRAMENTO COUNTY

A tentative Waste Discharge Requirements Order (Order) is proposed for the Vulcan Materials Company (Permittee), Carli Expansion Site – Phase T-2 Project (Project) in Sacramento County. The 70.5-acre Project will expand sand and gravel mining operations at the Sacramento Aggregates Mine and Processing Plant. The expanded mining operations will result in the excavation of approximately 0.09 acre of ephemeral drainages, 0.047 acre of seasonal wetlands, 0.75 acre of a ponded ditch, and 1.057 acre of a retention basin.

The tentative Order provides details of the proposed Project activities, including compensatory mitigation measures planned to compensate for the permanent loss of waters of the state and requiring avoidance and minimization measures to reduce onsite impacts during construction activities. The tentative Order describes technical conditions required to be met throughout the implementation of construction activities that allow for activities to meet Basin Plan objectives.
