RESCINDING WASTE DISCHARGE REQUIREMENTS

The California Regional Water Quality Control Board, Central Valley Region (Central Valley Water Board), finds that the Central Valley Water Board adopted the following Orders which are no longer applicable for the reasons shown:

**A. CALAVERAS UNIFIED SCHOOL DISTRICT, TOYON MIDDLE SCHOOL
WASTEWATER TREATMENT FACILITY, CALAVERAS COUNTY, WASTE
DISCHARGE REQUIREMENTS ORDER 97-074**

Waste Discharge Requirements Order 97-074, adopted on 25 April 1997, prescribes requirements for the Toyon Middle School Wastewater Treatment Facility in Calaveras County. On 19 May 2022, the Calaveras Unified School District submitted a Report of Waste Discharge to obtain coverage under the *Statewide General Order 2014-0153-DWQ for Small Domestic Wastewater Treatment Systems*. Regulation of the discharge was transferred to enrollment under General Order WQ 2014-0153-DWQ-R5397, which was issued by the Executive Officer on 12 June 2025. Therefore, it is appropriate to rescind Order 97-074.

**B. SENTINEL BUTTE WATER COMPANY AND CITY OF WOODLAKE
RECLAMATION PROJECT, TULARE COUNTY, WATER RECLAMATION
REQUIREMENTS ORDER NO. 5-01-082**

Water Reclamation Requirements (WRRs) Order No. 5-01-082, adopted on 27 April 2001, prescribes wastewater reclamation requirements for an agreement between Sentinel Butte Water Company (User) and the City of Woodlake (Producer) to reclaim undisinfected secondary treated wastewater from the Producer's wastewater treatment facility (WWTF) on 35 acres of pastureland (reclamation area) owned by the User (Assessor's Parcel Number 060-160-016). Wastewater treatment and disposal at the WWTF is regulated separately by Waste Discharge Requirements Order No. R5-2009-0103. On 22 February 2025, the Central Valley Water Board received an email request from the User to rescind WRRs Order No. 5-01-082, as the Facility has not received recycled water from the Producer for several years. On 20 March 2025, The Central Valley Water Board received a letter from the Producer confirming that recycled water is no longer sent to the User's reclamation area. On 6 May 2025, the Central Valley Water Board received a letter from the User signed by its President, Todd Conselasco, confirming that the reclamation area will no longer be receive recycled water from the Producer. In addition, the Producer's March 2025 letter included a revised water balance, signed and stamped by Steven Beck (RCE 43799), that demonstrates that sending recycled water to the reclamation area is not necessary for the WWTF to manage permitted flows. Therefore, it is appropriate to rescind WRRs Order No. 5-01-082.

**C. SIERRA SUNRISE, INC., MONTEVINA WINERY, AMADOR COUNTY,
WASTE DISCHARGE REQUIREMENTS ORDER 5-00-047**

Waste Discharge Requirements (WDRs) Order 5-00-047, adopted on 17 March 2000, prescribes requirements for Montevina Winery (Winery) in Amador County. On 3 June 2025, the Sierra Sunrise, Inc. (Discharger) submitted a letter requesting rescission of WDRs Order 5-00-047. The letter states that the Winery has ceased all winery operations and is no longer generating winery process wastewater under the current ownership. The facility has been closed since 23 December 2024, and the property is currently listed for sale. WDRs 5-00-047 is outdated and may not reflect future operation under the new ownership. Therefore, it is appropriate to rescind Order 5-00-047. If the Winery under the new ownership will generate winery process wastewater, then the new Winery owner must apply for coverage under *General Waste Discharge Requirements for Winery Process Water, Order WQ 2021-0002-DWQ* or site-specific Waste Discharge Requirements.

IT IS HEREBY ORDERED that the above Orders are rescinded on the date of this order unless otherwise stated above.
