NOTICE IS HEREBY GIVENTIES that the Central Valley Regional Water Quality Control Board (Central Valley Water Board) will consider Tentative Waste Discharge Requirements (WDRs) for Boundary Bend Olives, Inc.; Boundary Bend Assets Inc; Sue Schwarzgruber; Suzanne Horsley; C Mondavi and Family; and the Defty Fam Trust, through Trustee Spencer Defty (collectively, Discharger) as the owner of the land application operation and the owners of the land application areas, at a public meeting scheduled for:

The Final Agenda will provide the location and format of the meeting, the anticipated date that the proposed Order will be considered, and the anticipated Order of all agenda items; however, the Board may consider agenda items out of their listed Order. The agenda materials may also include staff revisions to the proposed Order.

Opportunities to Comment

The Central Valley Water Board will consider oral and written comments on the proposed Order before it votes on whether to adopt the Order.

The Board Chair may refuse to admit any comments or evidence received after the comment period unless the submitting party provides a reasonable explanation for why the submission is late and the Board Chair determines that admission of the late submission would not prejudice any other party.

Oral comments concerning the Order must be presented at the scheduled public meeting. Interested parties are generally allowed up to three minutes each to provide their comments. Certain **designated parties** may provide longer comments and have the right to call and examine witnesses, introduce exhibits, cross-examine opposing witnesses, impeach any witness, and to rebut the evidence against him or her. The party subject to the proposed Order is a designated party. Any other party may request recognition as a designated party by submitting a written statement of how they are directly affected by the discharge(s) to be regulated and why they would like to be considered a designated party. Such requests must be submitted to Central Valley Water no later than **5:00 p.m. on 13 April 2026**. Instructions on how to provide oral comments will be included in the Final Agenda for the meeting.

Proposed Order

If adopted, Waste Discharge Requirements (WDRs) Order R5-2026-00XX will prescribe requirements for the discharge of olive pomace to agricultural fields located at multiple sites within Yolo County. Boundary Bend Olives, Inc. owns and operates an olive oil production facility at 455 Harter Avenue in Woodland, Yolo County. Raw pomace consisting of crushed skins, pulp, and fragments of olive pits, generated during olive oil processing is land applied to agricultural fields for reuse.

The land application areas (LAAs) encompass approximately 8,279 acres across 49 parcels, organized into nine discrete areas. These parcels are under separate ownership. Parcel owners include Boundary Bend Olives, Inc; Boundary Bend Assets Inc; Sue Schwarzgruber; Suzanne Horsley; C Mondavi and Family, and the Defty Fam Trust, through its trustee Spencer Defty.

Boundary Bend Olives, Inc together with all named property owners of the LAAs, are jointly responsible for compliance with the requirements set forth in these WDRs
