The Final Agenda will provide the location and format of the meeting, the anticipated date that the proposed order will be considered, and the anticipated order of all agenda items; however, the Board may consider agenda items out of their listed order. The agenda materials may also include staff revisions to the proposed order.

Opportunities to Comment

The Central Valley Water Board will consider oral and written comments on the proposed Order before it votes on whether to adopt the Order.

The Board Chair may refuse to admit any comments or evidence received after the comment period unless the submitting party provides a reasonable explanation for why the submission is late and the Board Chair determines that admission of the late submission would not prejudice any other party.

Oral comments concerning the Order must be presented at the scheduled public meeting. Interested parties are generally allowed up to three minutes each to provide their comments. Certain **designated parties** may provide longer comments and have the right to call and examine witnesses, introduce exhibits, cross-examine opposing witnesses, impeach any witness, and to rebut the evidence against him or her. The party subject to the proposed Order is a designated party. Any other party may request recognition as a designated party by submitting a written statement of how they are directly affected by the discharge(s) to be regulated and why they would like to be considered a designated party. Such requests must be submitted to Central Valley Water Board no later than **5:00 p.m. on 2 March 2026**. Instructions on how to provide oral comments will be included in the Final Agenda for the meeting.

Proposed Order

If adopted, Waste Discharge Requirements (WDRs) Order R5-2026-XXXX will prescribe requirements for management of waste discharged from China Grade Sanitary Landfill, located at on County Dump Road. China Grade Sanitary landfill is owned by the County of Kern (Discharger). The Discharger will be responsible for maintaining compliance with Order requirements. The China Grade Sanitary Landfill is a Class III landfill that is in post-closure maintenance and corrective action. The Facility's waste discharges are

currently regulated under WDRs Order R5-2012-0123. If adopted, the proposed WDRs Order R5-2026-XXXX will rescind and replace the previous WDRs Order R5-2012-0123.
