The Central Valley Regional Water Quality Control Board (Central Valley Water Board) has prepared a draft Notice of Applicability for the Former Delta Cleaners Site in Brentwood California for coverage under General Order No. R5-2015-0012, *Waste Discharge Requirements General Order for In-situ Groundwater Remediation and Discharge of Treated Groundwater to Land*. Coverage under the General Order will allow the property owner to add specific compounds to groundwater for the breakdown of pollution at the property. Environmental assessment and remedial action are being performed under the oversight of the Central Valley Water Board.

Former Delta Cleaners

**Project Location:**

219 Oak Street, Brentwood, Contra Costa County

**Project Description:**

A dry-cleaning business formerly operated at 219 Oak Street. Tetrachloroethene, a chemical used in dry-cleaning, has been found to pollute groundwater beneath the property. The proposed project will be completed following the Central Valley Water Board approved June 2022 Remedial Action Plan. The project includes adding a mixture of bacteria, food-based supplement, and iron to the groundwater to clean up the pollution. The bacteria are naturally occurring species that can completely break down tetrachloroethene. The iron will also break down tetrachloroethene.

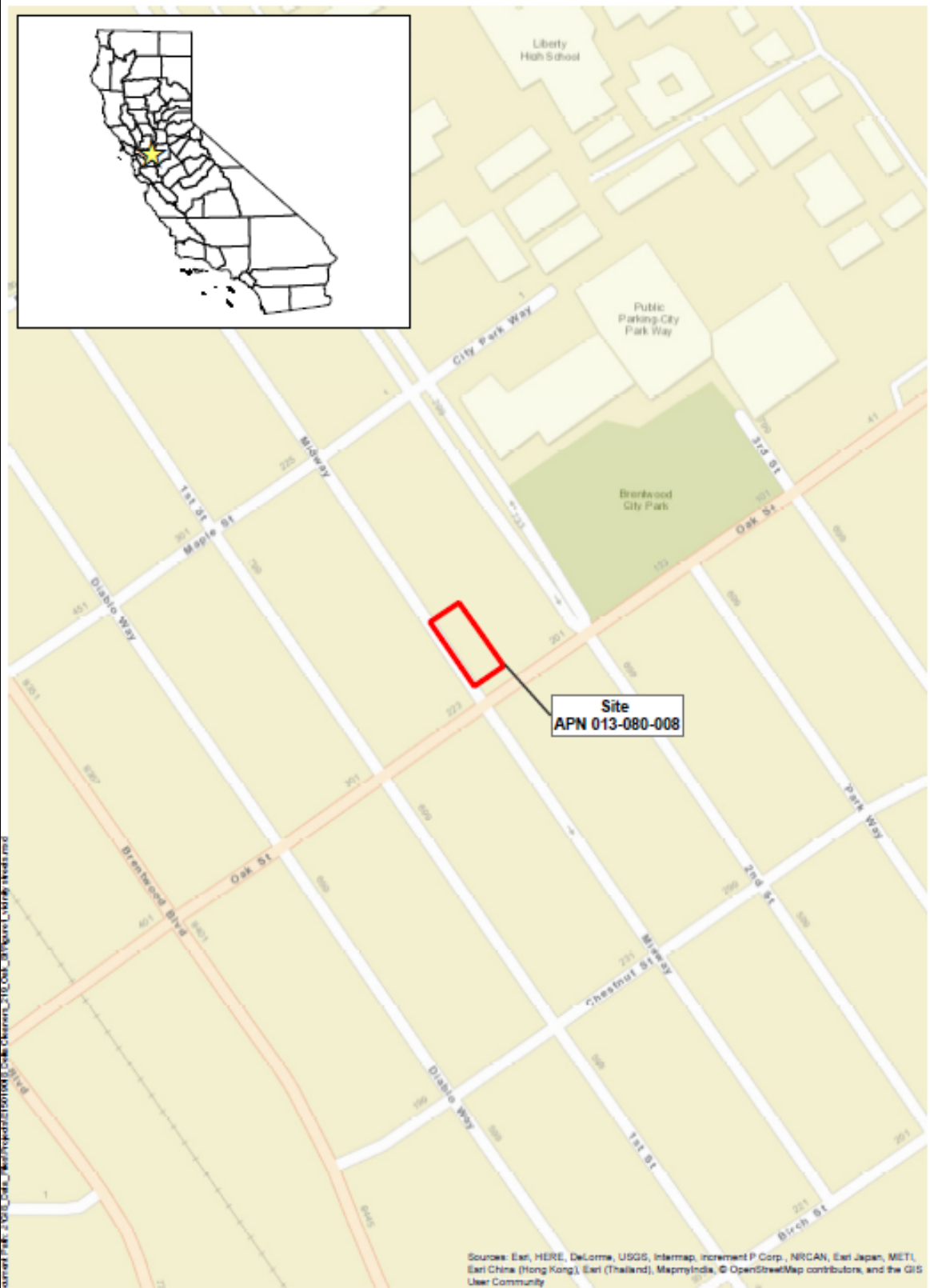

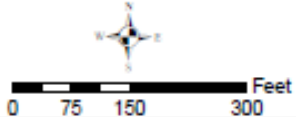
