### **Opportunities to Comment**

The Central Valley Water Board will consider oral and written comments on the proposed Order before it votes on whether to adopt the Order.

The Board Chair may refuse to admit any comments or evidence received after the comment period unless the submitting party provides a reasonable explanation for why the submission is late and the Board Chair determines that admission of the late submission would not prejudice any other party.

Oral comments concerning the Order must be presented at the scheduled public meeting. Interested parties are generally allowed up to three minutes each to provide their comments. Certain designated parties may provide longer comments and have the right to call and examine witnesses, introduce exhibits, cross-examine opposing witnesses, impeach any witness, and to rebut the evidence against him or her. The party subject to the proposed Order is designated parties. Any other party may request recognition as a designated party by submitting a written statement of how they are directly affected by the discharge(s) to be regulated and why they would like to be considered a designated party. Such requests must be submitted to Central Valley Water no later than 5:00 p.m. on 4 June 2026. Instructions on how to provide oral comments will be included in the Final Agenda for the meeting.

### **Proposed Order**

If adopted, the proposed Order will authorize a change of ownership of the hydroponic facility (Facility) located at 20570 Pellisier Road in Tehachapi, which is regulated by

Waste Discharge Requirements (WDRs) Order R5-2024-0041. The Facility was owned and operated by the Controlled Environment Foods Fund II (CEFF II) Tehachapi Property, LLC. The Facility is now owned and operated by Millennium Pacific Farms Inc. (Discharger) and will be known as the Millennium Tehachapi Greenhouse II. The Discharger will be responsible for maintaining compliance with the requirements of existing WDRs Order R5-2024-0041 that regulates the discharge of up to 70,000 gallons per day of wastewater generated from the growing and packaging process to land application areas and an unlined pond.

To conserve paper and reduce mailing costs, a paper copy of the proposed Order was sent only to the Discharger(s).
