Opportunities to Comment

The Central Valley Water Board will consider oral and written comments on the proposed Order before it votes on whether to adopt the Order.

Written comments or evidence concerning the Order must be submitted by 5:00 pm on 21 July 2025. The Board Chair may refuse to admit any comments or evidence received after the comment period unless the submitting party provides a reasonable explanation for why the submission is late and the Board Chair determines that admission of the late submission would not prejudice any other party.

Oral comments concerning the Order must be presented at the scheduled public meeting. Interested parties are generally allowed up to three minutes each to provide their comments. Certain **designated parties** may provide longer comments and have the right to call and examine witnesses, introduce exhibits, cross-examine opposing witnesses, impeach any witness, and to rebut the evidence against him or her. The party subject to the proposed Order is a designated party. Any other party may request recognition as a designated party by submitting a written statement of how they are directly affected by the discharge to be regulated and why they would like to be considered a designated party. Such requests must be submitted to Central Valley Water no later than **5:00 p.m. on 21 July 2025**. Instructions on how to provide oral comments will be included in the Final Agenda for the meeting.

To conserve paper and reduce mailing costs, a paper copy of the proposed Order was sent only to the Discharger(s).
