### **TENTATIVE RESCISSION OF WASTE DISCHARGE REQUIREMENTS ORDER 93-032, USDI NATIONAL PARK SERVICE, OAK BOTTOM RECREATIONAL AREA, WHISKEYTOWN LAKE, SHASTA COUNTY**

Enclosed is a tentative Waste Discharge Requirement Rescission for USDI National Park Service, Oak Bottom Recreational Area's wastewater treatment system in Whiskeytown, Shasta County. A Public Hearing has been scheduled for the Central Valley Water Board to consider adoption of tentative Order at its 31 May/1 June 2018 Board Meeting. For your facility to be included with the adopted orders, you must post the enclosed Notice of Public Hearing by **30 March 2018** at the following locations:

- The entrance to the facility;
- The nearest city hall or county courthouse; and
- The post office nearest to the facility (if allowed)

To verify the Notice of Public Hearing has been posted, a completed copy of the enclosed Proof of Posting form must be sent to our office by **2 April 2018**.

Any comments or recommendations you or others may have concerning the tentative Order must be submitted in writing to the Central Valley Regional Water Quality Control Board (Central Valley Water Board) office by 5 pm on **30 April 2018**. Written materials submitted after this date and time will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party. Please note that the tentative documents will receive internal legal and management review during the public comment period.

To conserve resources, this letter transmits a paper copy of the tentative documents to the discharger only. Interested persons are advised that the full text of the tentative documents is available on the Central Valley Water Board's website at:
