TENTATIVE WASTE DISCHARGE REQUIREMENTS FOR SIERRA PACIFIC INDUSTRIES ANDERSON DIVISION SHASTA COUNTY

TO ALL CONCERNED PERSONS AND AGENCIES:

The Central Valley Regional Water Quality Control Board (Central Valley Water Board) has prepared tentative Waste Discharge Requirements (WDRs) for the Anderson Division sawmill complex and cogeneration power plant (Facility), which is owned and operated by Sierra Pacific Industries. The Central Valley Water Board is currently soliciting public comments on the tentative Waste Discharge Requirements in accordance with the Notice of Public Hearing to Adopt Tentative Waste Discharge Requirements, which is attached to this letter.

A Public Hearing has been scheduled for the Central Valley Water Board to consider adoption of the tentative Waste Discharge Requirements at its **5/6 April 2018** Board Meeting. For your Facility to be included with the adopted orders, you must post the enclosed Notice of Public Hearing by **29 January 2018** at the following locations:

- The entrance to the Facility;
- The nearest city hall or county courthouse; and
- The post office nearest to the Facility (if allowed).

To verify the Notice of Public Hearing has been posted, a completed copy of the enclosed Proof of Posting form must be sent to our office by **1 February 2018**.

To conserve resources, this letter transmits a paper copy of the tentative WDRs to the Dischargers only. All other persons are advised that the full text of the tentative documents is available on the Central Valley Water Board's web site at:


