NOTICE OF PUBLIC HEARING concerning TENTATIVE WASTE DISCHARGE REQUIREMENTS FOR TRINITY RIVER LUMBER COMPANY AND CWS ENTERPRISES, INC. TRINITY RIVER LUMBER COMPANY LOG YARD BUTTE COUNTY

NOTICE IS HEREBY GIVEN that the Central Valley Regional Water Quality Control Board (Central Valley Water Board) will consider adoption of the subject Order at a public meeting scheduled for:

The date, time, and location of the public meeting may change after this Notice is issued. A Final Agenda for the meeting will be made available at least 10 days before the meeting. The Final Agenda will provide the location and format of the meeting, the anticipated date that the proposed order will be considered, and the anticipated order of all agenda items; however, the Board may consider agenda items out of their listed order. The agenda materials may also include staff revisions to the proposed order. Opportunities to Comment

The Central Valley Water Board will consider written and oral comments on the proposed Order before it votes on whether to adopt the Order.

Written comments or evidence concerning the Order must be submitted by 5:00 p.m. on 4 September 2026. The Board Chair may refuse to admit any late submissions unless the submitting party provides a reasonable explanation for why the submission is late and the Board Chair determines that admission of the late submission would not prejudice any other party.

Oral comments concerning the Order must be presented at the scheduled public meeting. Instructions for how to provide oral comments will be included in the Final Agenda for the meeting.

Parties to the Proceeding and Interested Persons

Participants in the hearing will be considered "parties" or "interested persons."

Parties include the person to whom the agency action is directed and any other person whom the Board determines should be designated as a party. Parties may present written evidence, offer witness testimony, cross-examine witnesses, and provide closing statements. At the time of this Notice, the party(s) to this action are: Trinity River Lumber Company and CWS Enterprises Inc.

Interested Persons are those individuals and organizations that are interested in the outcome of the hearing who have not been designated as a party. Interested persons are generally allowed up to three minutes each to provide oral comments during the Board meeting. Interested persons may request that the Board Chair authorize a longer time period for their comments.

Both Parties and Interested Persons may be asked to respond to questions from the Board or its staff.

Proposed Order

If adopted, Waste Discharge Requirements (WDRs) Order R5-2026-XXXX will prescribe requirements for management of waste discharged from Trinity River Lumber Company Log Yard, located at 3000 South 7th Avenue, Oroville, Butte County. Trinity River Lumber Company Log Yard is owned by CWS Enterprises Inc. and operated by Trinity River Lumber Company (collectively, Discharger(s)). The Discharger(s) will be responsible for maintaining compliance with Order requirements. The facility (Facility) consists of a 15 acre parcel with an approximately 5.5 acre unpaved log deck and an unlined pond. Water from an onsite supply well and a retention/recycle pond are pumped into a sprinkler system that sprinkles the logs on the log deck. Runoff from the sprinkler system and all stormwater runoff from the log deck drain into the pond and is recycled back through the sprinkler system. Infiltration occurs on the log deck and in the unlined pond. The Facility's waste discharges are not currently regulated by a WDR Order.

To conserve paper and reduce mailing costs, a paper copy of the proposed Order was sent only to the Discharger(s). Other Information

Any person or organization may request to be recognized as a party to the proceeding by submitting a written statement describing why they would like to be considered a party, their interest in presenting evidence rather than policy statements or legal arguments, and an acknowledgement that those testifying may be subject to cross examination consistent with applicable regulations. Such requests must be submitted to Central Valley Water Board **no later than 5:00 PM on 4 September 2026**.
