TENTATIVE RESCISSION OF WASTE DISCHARGE REQUIREMENTS ORDER 99-123 FOR TRIPLE E PRODUCE, SAN JOAQUIN COUNTY TO ALL CONCERNED PERSONS AND AGENCIES:

Enclosed is a tentative Rescission Order to rescind the Triple E Produce Waste Discharge Requirements Order 99-123 in San Joaquin County. The Central Valley Water Board will consider adoption of the tentative Rescission Order at its 22/23 April 2021 meeting. Any written comments or evidence you may have concerning the rescission of WDRs must be submitted to this office by 5:00 p.m. on 25 March 2021. Absent a showing of good cause and lack of prejudice to other parties, the Board Chair may exclude comments and evidence received after this deadline.

To conserve paper and reduce mailing costs, a paper copy of the tentative Rescission Order has been sent only to the Discharger.
