The Regents, University of California is the owner of the University of California, Davis Wastewater Treatment Plant (Facility), a publicly owned treatment works located at 561 Trotter Way, Davis, California. The University of California, Davis is the Facility operator. The Facility provides sewerage services for the University of California, Davis, serving a campus population of approximately 48,000. The Facility provides tertiary treatment for up to an average dry weather flow of 3.6 million gallons per day (MGD). Tertiary-treated wastewater from the Facility is discharged to the South Fork of Putah Creek, a water of the United States.

Discharges from the Facility are currently regulated by Waste Discharge Requirements Order R5-2014-0152, issued by the Central Valley Regional Water Quality Control Board (Central Valley Water Board) on 5 December 2014. An Order is proposed to renew the NPDES permit. The proposed permit includes new or updated effluent limitations for ammonia nitrogen, nitrate plus nitrite, mercury, and electrical conductivity. The proposed permit will remove existing effluent limitations for total residual chlorine because chlorine is no longer used at the Facility. The proposed permit will also remove the mass limits for biochemical oxygen demand (BOD₅) and the mass limits for total suspended solids (TSS) because the mass-based limits for BOD₅ and TSS are redundant. Removal of these limits will not result in an increase in the pollutants or in the degradation of the receiving water.

explain the basis for status as a designated party and in particular how the person is directly affected by the discharge.

Persons wishing to comment on this noticed hearing item shall submit testimony, evidence, if any, and/or comments in writing to the Central Valley Water Board email at RB5S-NPDES-Comments@waterboards.ca.gov no later than **5:00 p.m. on 23 November 2020**. Written evidence or comments submitted after **5:00 p.m. on 23 November 2020** will not be accepted and will not be incorporated into the administrative record absent a ruling by the Board Chair. Any party requesting to submit late materials must demonstrate good cause for the late submission, and the Chair must find that accepting the late submission will not prejudice the Central Valley Water Board or any Designated Party.

All designated parties and interested persons may speak at the Central Valley Water Board meeting, and are expected to orally summarize their written submittals. Oral testimony and cross examination will be limited in time by the Board Chair.
