NOTICE OF TENTATIVE RESOLUTION FOR THE UNITED STATES ARMY CORPS OF ENGINEERS, AUTHORIZING THE EXECUTIVE OFFICER TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH THE UNITED STATES ARMY CORPS OF ENGINEERS, SAN FRANCISCO DISTRICT CONCERNING OPERATIONS AND MAINTENANCE DREDGING OF STOCKTON AND SACRAMENTO DEEP WATER SHIP CHANNELS, SACRAMENTO, SAN JOAQUIN, AND SOLANO COUNTIES

TO ALL CONCERNED PERSONS AND AGENCIES:

Enclosed is a tentative Resolution to amend the existing resolution authorizing the Executive Officer to enter into a Memorandum of Understanding with the Army Corps of Engineers, San Francisco District, concerning operations and maintenance of Stockton and Sacramento Deep Water Ship Channels in Sacramento, San Joaquin, and Solano Counties.

The tentative Resolution proposes to add alternative dredging methods, McDonald Island as a dredge material placement site, and other minor dredging operation updates.

A public hearing concerning this matter will be held during the Central Valley Regional Water Quality Control Board (Central Valley Water Board) meeting scheduled for:
