The Final Agenda will provide the location and format of the meeting, the anticipated date that the proposed order will be considered, and the anticipated order of all agenda items; however, the Board may consider agenda items out of their listed order. The agenda materials may also include staff revisions to the proposed order.

### **Opportunities to Comment**

The Central Valley Water Board will consider oral and written comments on the proposed Order before it votes on whether to adopt the Order.

The Board Chair may refuse to admit any comments or evidence received after the comment period unless the submitting party provides a reasonable explanation for why the submission is late and the Board Chair determines that admission of the late submission would not prejudice any other party.

**Oral comments** concerning the Order must be presented at the scheduled public meeting. Interested parties are generally allowed up to three minutes each to provide their comments. Certain **designated parties** may provide longer comments and have the right to call and examine witnesses, introduce exhibits, cross-examine opposing witnesses, impeach any witness, and to rebut the evidence against him or her. The party subject to the proposed Order is designated parties. Any other party may request recognition as a designated party by submitting a written statement of how they are directly affected by the discharge(s) to be regulated and why they would like to be considered a designated party. Such requests must be submitted to Central Valley Water no later than 5:00 p.m. on 23 February 2026. Instructions on how to provide oral comments will be included in the Final Agenda for the meeting.

### **Proposed Order**

If adopted, the proposed Order will recognize the change of ownership for a packing facility located at 8994 E. Central Avenue in Del Rey that was previously owned and operated by Vita-Pakt Citrus Products Co. The facility is now owned and operated by

Vita-Pakt Citrus Products, LLC (Discharger), and will be now known as the “Vita-Pakt Del Rey Plant” (Del Rey Plant). The Del Rey Plant is regulated by WDRs Order No. 96-119, which authorizes the discharge of up to 0.042 million gallons per day (mgd) from August to September and 0.002 mgd for the remainder of the year to a land application area. The Discharger will be responsible for maintaining compliance with the requirements of existing WDRs Order No. 96-119 at the Del Rey Plant.

To conserve paper and reduce mailing costs, a paper copy of the proposed Order was sent only to the Discharger(s).
