Discharger and Tentative Order Information

The City of Woodland (Discharger) is the owner and operator of the Water Pollution Control Facility (Facility), located at 42929 County Road 24, Woodland, California. The Discharger provides sewerage service for the City of Woodland and serves a population of approximately 59,000. The design daily average flow capacity of the Facility is 10.4 million gallons per day (MGD). From August 2021 through July 2024, the average surface water discharge was 3.5 MGD. The Facility receives wastewater from domestic sources and one permitted non-domestic discharger. The Facility discharges tertiary-treated municipal wastewater to Tule Canal, a water of the United States within the Yolo Bypass, and primary and secondary treated municipal wastewater in the Facility's algae production ponds to groundwater.

Discharges from the Facility are currently regulated by Waste Discharge Requirements Order R5-2020-0015, issued by the Central Valley Regional Water Quality Control Board (Central Valley Water Board) on 16 April 2020. An Order is proposed to renew the NPDES permit. The tentative Order includes new or updated effluent limitations for ammonia, nitrate plus nitrite, total selenium, and chronic toxicity. The tentative Order removes effluent limits for acute toxicity and the performance-based effluent limitation for electrical conductivity. The tentative Order also expands groundwater monitoring and includes pond monitoring in lieu of monitoring the wastewater water being discharged to the ponds.

date the hearing will be held for this item and anticipated order of all agenda items; however, the Board may consider agenda items out of their listed order. The agenda materials may also include staff revisions to the tentative Order.

Nature and Purpose of Hearing

At the hearing, the Central Valley Water Board will hear testimony and oral comments regarding the tentative Order. This proceeding will be a formal adjudicatory proceeding. The <u>procedures governing Central Valley Water Board adjudicatory hearings</u>

<u>Prehearing Submission of Written Comments and Evidence</u>

The **Discharger** is a party to this proceeding. As a party, the Discharger must submit written evidence or comments, if any, for the Board to consider **no later than 5:00 p.m. on 7 January 2026** to the Central Valley Water Board email at RB5S-NPDES-Comments@waterboards.ca.gov.

Interested persons include any non-party that is interested in the outcome of the hearing. Interested persons wishing to comment, in writing, on the tentative Order shall submit comments **no later than 5:00 p.m. on 7 January 2026** to the Central Valley Water Board email at RB5S-NPDES-Comments@waterboards.ca.gov.

Pursuant to California Code of Regulations, title 23, section 648.4, the Board Chair may refuse to admit written evidence or comments that are not submitted in accordance with this Notice and shall refuse to do so when there is a showing of prejudice to the Discharger or the Board. Excluded material will not be considered by the Board.

Requesting Party Status

Persons who wish to participate in the hearing as a party must submit a request in writing no later than 5:00 p.m. on 19 December 2025 to the Central Valley Water Board email at RB5S-NPDES-Comments@waterboards.ca.gov. The request must include facts demonstrating how the person will be substantially affected by the proceeding.

The Board Chair will not designate a person as a party if the Board Chair determines the designation will impair the interests of justice and the orderly and prompt conduct of the proceeding. The Board Chair, when granting a request for party status, may impose restrictions on the requestor's hearing participation, including limiting or excluding the use of cross-examination and other procedures to promote the orderly and prompt conduct of the proceeding.

Visual Presentations

Hearing participants may use PowerPoint or other visual presentations at the hearing, but the presentation content shall not exceed the scope of previously submitted written material. Presentations, if any, must be provided to the below Central Valley Water Board Contact by 12:00 p.m. on 23 February 2026.

Hearing Procedure and Time Limits

The hearing on the tentative Order will be conducted in the general order listed under California Code of Regulations, title 23, section 648.5, except that the Board Chair may modify the order for good cause.

The **Discharger** and any other designated Party will be advised in advance of the hearing of the total amount of time allocated for their presentation and closing statement. The Discharger and

other designated Parties are invited to contact staff in advance of the hearing to discuss how much time they believe is necessary.

Interested persons may speak at the hearing and are expected to orally summarize their written submittals, if any. Each interested person will have 3 minutes to present oral comments. Additional time may be provided, upon request, at the discretion of the Board Chair.

Hearing Accommodations

The hearing facilities will be accessible to persons with disabilities.
