NOTICE IS HEREBY GIVEN that the Central Valley Regional Water Quality Control Board (Central Valley Water Board) will consider adoption of the subject Order at a public meeting scheduled for:

The Final Agenda will provide the location and format of the meeting, the anticipated date that the proposed order will be considered, and the anticipated order of all agenda items; however, the Board may consider agenda items out of their listed order. The agenda materials may also include staff revisions to the proposed order.

Opportunities to Comment

The Central Valley Water Board will consider oral and written comments on the proposed Order before it votes on whether to adopt the Order.

The Board Chair may refuse to admit any comments or evidence received after the comment period unless the submitting party provides a reasonable explanation for why the submission is late and the Board Chair determines that admission of the late submission would not prejudice any other party.

Oral comments concerning the Order must be presented at the scheduled public meeting. Interested parties are generally allowed up to three minutes each to provide their comments. Certain designated parties may provide longer comments and have the right to call and examine witnesses, introduce exhibits, cross-examine opposing witnesses, impeach any witness, and to rebut the evidence against him or her. The party subject to the proposed Order is the designated party. Any other party may request recognition as a designated party by submitting a written statement of how they are directly affected by the discharge(s) to be regulated and why they would like to be considered a designated party. Such requests must be submitted to Central Valley Water Board no later than 5:00 p.m. on **14 October 2026**. Instructions on how to provide oral comments will be included in the Final Agenda for the meeting.

Proposed Order

Zamora Pistachio, LLC (Discharger) owns and operates the Zamora Pistachio Facility located at 33700 County Road 13, east of Zamora in Yolo County. The Facility is currently regulated under Waste Discharge Requirements (WDRs) R5-2024-0035, adopted on 21 June 2024. Process wastewater is generated from hulling, equipment cleanup/wash down, and pasteurizer condensate. Wastewater is primarily from the hulling, sorting and washing of nuts. Discharge is to a clay-lined pond then applied to approximately 440 acres cropped with pistachio orchards and cover crops.

The Discharger proposes to revise the wastewater pond design by replacing the previously proposed single clay-lined pond with two 60-mil high-density polyethylene (HDPE) lined ponds. If adopted, the tentative Order will amend WDRs R5-2024-0035 to incorporate these design changes.

The proposed Order would require regular inspection of the liner condition and a leak test at least once every five years.

To conserve paper and reduce mailing costs, a paper copy of the proposed Order was sent only to the Discharger(s).
