## Public Notice: Proposed Cleanup Program Site Case Closure

Kent's Oil Service (T1000003186) 3310 E Miner Avenue Stockton, San Joaquin County, CA

This property, currently operating as Pacific Northwest Oil, has been the location of an industrial asphalting oil supplier and transfer facility since at least 1991. In 2010, a hose transferring diesel fuel from a tanker truck to an above ground storage tank failed and discharged approximately 200 gallons of diesel fuel to the immediate area. The facility operator was able to generally contain the release to prevent it from entering a nearby storm drain. A map of the property showing the approximate release location is provided at the end of this notice.

The property owner cleaned up the release by excavating and disposing of approximately 60 tons of diesel fuel impacted chip-sealed surfacing and soil. Soil samples collected after excavation were reported to contain diesel fuel at concentrations that did not pose a risk to human health or the environment. The lab that analyzed the soil samples also noted that the samples primarily contained petroleum chemicals related to asphalt that would be reported as diesel fuel. Based on these sample results, Central Valley Water Board staff is proposing this case should be closed.

Staff is issuing this Public Notice to provide the public an opportunity to comment on the proposed case closure. Any person wishing to comment on the closure of this case has 60 days to do so. The public comment period is listed below.
