

## THIRD PARTY PROCESS WASTEWATER AGREEMENT

This agreement is between the Dairy Operator (Process Wastewater Supplier) and the Third Party (Process Wastewater Recipient) that receives process wastewater (lagoon/nutrient water) from the Dairy Operator as identified below.

**The Dairy Operator agrees to:**

1. Complete a Manure/Process Wastewater Tracking Manifest (Attachment D of Waste Discharge Requirements General Order No. R5-2007-0035 for Existing Milk Cow Dairies) for each transfer (whether by pipeline, truck, or other means) of process wastewater to the Third Party, and
2. Include copies of each Manure/Process Wastewater Tracking Manifest in the Annual Monitoring Report as required in Waste Discharge Requirements General Order No. R5-2007-0035 for Existing Milk Cow Dairies.

**The Third Party agrees to:**

1. Use all process wastewater received from the Dairy Operator in the areas and for the crop(s) identified above by the Third Party at agronomic rates appropriate for the crops to be grown.
2. Handle process wastewater carefully and in a manner that prevents runoff to surface waters of any process wastewater, storm water or irrigation supply water that has come into contact with manure or is blended with process wastewater. Special attention is warranted in situations where process wastewater is co-mingled with fresh water to prevent backflow conditions which may result in discharge to surface or ground water.

2. Send a Notice of Termination to the other party and copied to the Central Valley Regional Water Quality Control Board no less than 60 days in advance of the termination date.
