**Central Valley Regional Water Quality Control Board**

**SECOND REVISED NOTICE OF PUBLIC HEARING  
9 November 2012**

The California Regional Water Quality Control Board, Central Valley Region (Central Valley Water Board) has released tentative waste discharge requirements (WDRs) and a tentative monitoring and reporting program (MRP) for discharges from irrigated lands within the Eastern San Joaquin River watershed (Eastern San Joaquin River Watershed Order or tentative Order). The tentative WDRs and MRP rely on the Irrigated Lands Regulatory Program, Program Environmental Impact Report (Resolution R5-2011-0017) for California Environmental Quality Act compliance.

If a quorum of the Board is present in Bakersfield, the public hearing concerning this matter will be opened in Bakersfield on 30 November 2012, and the hearing will be continued in Rancho Cordova on 7 December 2012 for receipt of additional testimony and comments and consideration of adoption of the tentative WDRs and MRP. If a quorum of the Board is not present in Bakersfield, the Board will hold a public workshop instead of a hearing in Bakersfield on 30 November, and then open the hearing in Rancho Cordova on 7 December for testimony and comments and consideration of adoption of the tentative WDRs and MRP.

Whether the Bakersfield meeting is considered to be a hearing or a workshop:

- All testimony and oral comments in Bakersfield will be recorded and made part of the record of the hearing,
- Concerns expressed in Bakersfield will be summarized for the Board members at the hearing in Rancho Cordova

It is not necessary for those who address the Board in Bakersfield to travel to Rancho Cordova and speak again at the 7 December hearing. However, if a workshop is held, anyone who addresses the Board in Bakersfield is free to speak again at the Rancho Cordova hearing.

The board will consider adoption of the tentative WDRs and MRP on December 7, 2012 in Rancho Cordova, which will be the first of the irrigated lands general orders considered for adoption. Although it is planned that each order will be tailored to the needs of the individual watershed area, stakeholders in the Tulare Lake Basin have expressed considerable concern that the Eastern San Joaquin River Watershed Order will set precedent for all future orders. The Board has received numerous requests from interested parties in the southern San Joaquin Valley for the opportunity to comment on the proposed Eastern San Joaquin River Watershed order. The board will therefore conduct a special meeting in Bakersfield to allow stakeholders in the southern San Joaquin Valley to address the Board at a convenient location. Stakeholders include affected members of the community, regulated entities, their representatives, and all other persons who are interested in this matter. The item will be continued to the December 7 meeting in Rancho Cordova where stakeholders may also address the Board. At the December 7 meeting, the Board expects to deliberate and vote on the proposed order. Transcripts and/or audiotapes of both the Bakersfield and Rancho Cordova meetings will be part of the record of the action and will be considered by the Board.

Comments and testimony on the East San Joaquin River Watershed order given at both the Bakersfield and Rancho Cordova meetings will be part of the record of the action and will be considered by the Board. There is no need for stakeholders to repeat comments or testimony at both meetings. Very limited Central Valley Water Board staff presentations will be made at the Bakersfield meeting to maximize the time available for public comments on the proposed order. A full board staff presentation will be made at the Rancho Cordova meeting.

Written comments on this item **were** due **on 6 August 2012**. Additional written comments will **not** be received on this item. Materials received by 6 August have been included in the administrative record and a response to those comments will be prepared. Written comments shall not be read into the record unless allowed by the Water Board Chair.

Interested persons will be provided the opportunity to present oral comments to the Central Valley Water Board at the meetings. Oral testimony will be limited in time by the Central Valley Water Board Chair. Interested persons may be asked to respond to clarifying questions from Central Valley Water Board members, counsel, staff, or others, at the discretion of the Central Valley Water Board Chair. The Chair may, at his discretion, allow presenters to supplement their oral testimony with slides or other digital media. If you plan to use visual aids such as PowerPoint slides, contact staff prior to the meeting to arrange for equipment set-up. You must provide a printed or electronic copy of any visual aids.

Hearings before the Central Valley Water Board are not conducted pursuant to Government Code section 11500 et seq.
