

## APPENDIX F: LANDOWNER INFORMATION ON USE OF GROUNDWATER FOR STOCK WATERING IN THE PROJECT STUDY AREA

Staff from Tulare Lake Drainage District and Tulare Lake Basin Water Storage District met with landowners in the proposed AGR de-designation area to determine if they were, or if they plan to use in the future groundwater pumped from the project study area for watering livestock. These meetings took place in December 2013 and March 2015. The landowners contacted and the water sources they use for watering their livestock are provided in the table below.
