COLORADO RIVER BASIN REGION ORDER NO. 78-63 WASTE DISCHARGE REQUIREMENTS FOR LA QUINTA HOTEL La Quinta - Riverside County The California Regional Water Quality Control Board, Colorado River Basin Region finds that: submitted a report of waste discharge, dated May 12, 1978. 2.

- - Landmark Land Company (hereinafter also referred to as the discharger), P.O. Box 69, La Quinta, CA 92253,
  - The discharger proposes to discharge a total maximum average of 34,500 gallons-per-day of domestic sewage from 75 existing hotel units and 26 proposed hotel units. The wastewater is currently discharged into a septic tank leach field disposal system located in the  $SE_{4}^{2}$  of the  $SW_{4}^{1}$  of Section 36, T6S, R6E, SBB&M. The discharger proposes to expand the disposal facilities by adding a seepage pit disposal field in the  $NW_{4}^{1}$ ,  $NE_{4}^{1}$ ,  $NE_{4}^{1}$  of Section 1, T6S, R6E, SBB&M.
  - The discharger has reserved areas of sufficient size for 100% replacement of the seepage pits and the leach field. These areas are designated on Attachment "A" incorporated herein and made a part of this Order.
  - The discharger states that wastewater from a swimming pool is periodically discharged onto a date orchard.
  - 5. The Water Quality Control Plan for the West Colorado River Basin was adopted by the Board on April 10, 1975. The Basin Plan contains water quality objectives for the Coachella Hydrologic Subunit.
  - The beneficial uses of the groundwater of the Coachella Hydrologic Subunit are:
    - Municipal supply
    - Industrial supply
    - Agricultural supply


The Board has notified the discharger and interested 7. agencies and persons of its intent to prescribe waste discharge requirements for the proposed discharge. The Board in a public meeting heard and considered all 8. comments pertaining to the proposed discharge. Harry H. Schmitz and Associates submitted to the Riverside County Planning Commission an Environmental Impact Report (dated July, 1974) which includes an environmental assessment of said proposed hotel This report indicates that this project will not have any significant adverse effects on the environment. IT IS HEREBY ORDERED, the discharger shall comply with the following: A. Discharge Specifications Neither the treatment nor the discharge of wastewater shall create a pollution or a nuisance as defined in Division 7 of the California Water Code. No wastewater other than domestic sewage shall be 2. discharged at this location. Wastewater discharged subsurface shall be retained underground with no surfacing. There shall be no discharge of sewage within 200 feet of any domestic water well. Adequate measures shall be taken to assure that flood 5. or surface drainage waters do not erode or otherwise render portions of the discharge facilities inoperable. 6. Septic tank cleanings shall be discharged only by a duly authorized service. Swimming pool wastewater shall not be discharged into 7. a sewage disposal system. B. Provisions 1. The areas reserved for 100% replacement of the seepage pits and the leach field, as shown on Attachment "A", shall at all times be retained servient to this hotel complex, for the purpose of providing additional subsurface sewage disposal capacity, until such time as this complex is connected to a municipal sewerage system. -2-

- 2. Upon request from this Board's Executive Officer, the discharger shall furnish technical and/or monitoring reports on the treatment and discharge of wastes.
- 3. Prior to any modifications in this facility which would result in material change in the quality or quantity of wastewater discharged, or any material change in location of discharge, the discharger shall report in writing to the Regional Board.
- 4. Prior to any future change of ownership of this hotel complex, the discharger shall:
  - a. Specify as a condition of transfer that said sewage disposal areas must remain servient to the hotel, for the purpose of providing subsurface sewage disposal capacity, until such time as this complex is connected to a municipal sewerage system.
  - b. Notify the succeeding owner, in writing, of the existence of this Order, and forward a copy of said correspondence to the Regional Board.


## SITE MAP
