
CALIFORNIA REGIONAL WATER QUALITY CONTROL BOARD COLORADO RIVER BASIN REGION ORDER NO. 79-33 WASTE DISCHARGE REQUIREMENTS VISTA MONTANA aka Sunny Springs Southeast of Desert Hot Springs - Riverside County The California Regional Water Quality Control Board, Colorado River Basin Region, finds that: 1. Clare Lee, et. al. (hereinafter also referred to as the discharger), 66414 West 6th Street, Desert Hot Springs, CA 92240, submitted a Report of Waste Discharge dated December 13, 1978. 2. The discharger proposes to discharge a maximum average of 38,000 gallons-per-day of domestic sewage from a mobile home and recreational vehicle park designed to have 192 mobile home spaces, 36 recreational vehicle spaces, a laundry room and 2 restrooms. The wastewater is to be discharged into septic tank/seepage pit disposal systems located in the NW 1/4 of the SE 1/4 of Section 11, T3S, R5E, SBB&M. The discharger is reserving areas of sufficient size for possible future 100 percent replacement of each of the seepage pits. 4. There are no domestic wells within 200 feet of the proposed discharge facilities described in Findings No. 2 and 3, (above). 5. The discharger states that wastewater from a swimming pool and two hot pools is to be periodically discharged onto landscape plantings. 6. The Water Quality Control Plan for the West Colorado River Basin was adopted by the Board on April 10, 1975. The Basin Plan contains water quality objectives for the Coachella Hydrologic Subunit. The beneficial uses of the groundwaters of the Coachella Hydro-7. logic Subunit are: Municipal supply a. Industrial supply . b. c. Agricultural supply. The proposed development is located in the Miracle Hill Subarea of the Coachella Hydrologic Subunit. Groundwater in this location is warm and mineralized and is used in hot mineral pools and for landscape Rescinded by 86-519186irrigation.

9. The Board has notified the discharger and interested agencies and persons of its intent to prescribe waste discharge requirements for the proposed discharge. 10. The Board in a public meeting heard and considered all comments pertaining to the proposed discharge. . 11. The Riverside County Planning Department has prepared Negative Declaration EA No. 10336 (filing date February 5, 1979) for this proposed park. The Regional Board has reviewed this Negative Declaration and has determined that this project will not have any significant adverse effects on water quality. IT IS HEREBY ORDERED, the discharger shall comply with the following: Α. Discharge Specifications Neither the treatment nor the discharge of wastewater shall create a pollution or a nuisance as defined in Division 7 of the California Water Code. No wastewater other than domestic sewage and swimming pool and hot pool wastewater shall be discharged at this location. Wastewater discharged subsurface shall be retained underground with no surfacing. Adequate measures shall be taken to assure that flood or surface drainage waters do not erode or otherwise render portions of the discharge facilities inoperable. 5. Septic tank cleanings shall be discharged only by a duly authorized service. Swimming pool and hot pool wastewater shall not be discharged 6. into a sewage disposal system. Provisions В. Sufficient land area shall be reserved for possible future 100 percent replacement of the seepage pits, until such time as this park is connected to a municipal sewerage system. -2-

Upon request from this Board's Executive Officer, the discharger shall furnish technical and/or monitoring reports on the treatment and discharge of wastes. Prior to any modifications in this facility which would result in material change in the quality or quantity of wastewater discharged, or any material change in location of discharge, the discharger shall report in writing to the Regional Board. Prior to any change of ownership of this mobile home and recreational vehicle park, the discharger shall: Specify as a condition of transfer that said sewage disposal areas must remain servient to the park, for the purpose of providing subsurface sewage disposal capacity, until such time as this park is connected to a municipal sewerage system. Notify the succeeding owner, in writing, of the existence of this Order, and forward a copy of said correspondence to the Regional Board. CALIFORNIA REGIONAL WATER QUALITY CONTROL BOARD COLORADO RIVER BASIN REGION Transmittal of REQUIREMENTS AND RECOMMENDATIONS OF OTHER GOVERNMENTAL AGENCIES The State Department of Public Health, Hazardous Materials Management Section, requires that disposal facilities of mobile home and recreational vehicle parks be operated in conformance with the following regulation: There shall be no discharge of chemical toilet wastes which contain a nonbiodegradable toxic chemical substance as specified in Section 60291 of the California Health and Safety Code.
