ORDER NO. 85-30

WASTE DISCHARGE REQUIREMENTS FOR MISSION LAKES COUNTRY CLUB HOLIDAY HOUSE Northwest of Desert Hot Springs - Riverside County

The California Regional Water Quality Control Board, Colorado River Basin Region, finds that:

- 1. Mission Lakes Holiday House Assn. (hereinafter also referred to as the discharger), P. O. Box 1205, Desert Hot Springs, California, 92240, submitted updated information on the discharge of waste, dated January 11, 1985.
- 2. The discharger is discharging a maximum average of 34,000 gallons-per-day of domestic sewage from a 168 unit condominium development through septic tanks into seepage pits located in the SW4 of Section 23, T2S, R4E, SBB&M. Laundry wastewater is discharged through a lint trap into a seepage pit.
- 3. The discharger is reserving areas of sufficient size for possible future 100 percent replacement of the seepage pits.
- 4. The discharge has been subject to waste discharge requirements contained in Board Order No. 78-39.
- 5. There are no domestic wells within 200 feet of the discharge facilities described in Findings No. 2 and 3 (above).
- 6. The Water Quality Control Plan for the Colorado River Basin Region of California was adopted by the Regional Board on November 14, 1985. The Basin Plan contains water quality objectives for the Coachella Hydrologic Subunit.
- 7. The beneficial uses of the ground waters of the Coachella Hydrologic Subunit are:
 - a. Municipal supply
 - b. Industrial supply
 - c. Agricultural supply
- 8. The discharger states that wastewater from a swimming pool and a hot pool is periodically discharged onto landscape plantings.

- 1. Neither the treatment nor the discharge of wastewater shall create a pollution or a nuisance as defined in Division 7 of the California Water Code.
- 2. No wastewater other than domestic sewage and swimming and hot pool wastewater shall be discharged at this location.
- 3. Wastewater discharged subsurface shall be retained underground with no surfacing.
- 4. Adequate measures shall be taken to assure that flood or surface drainage waters do not erode or otherwise render portions of the discharge facilities inoperable.
- 5. Septic tank cleanings shall be discharged only by a duly authorized service.
- 6. Swimming pool and hot pool wastewater shall not be discharged into a sewage disposal system.

B. Provisions

- 1. Sufficient land area shall be reserved for possible future 100 percent replacement of the seepage pits, until such time as this park is connected to a municipal sewerage system.
- 2. Upon request from this Board's Executive Officer, the discharger shall furnish technical and/or monitoring reports on the treatment and discharge of wastes.
- 3. Prior to any modification of this facility which would result in material change in the quality or quantity of wastewater discharged, or any material change in location of discharge, the discharger shall report in writing to the Regional Board.
- 4. Prior to any change of ownership of this mobile home park, the discharger shall:


