ORDER NO. 85-57

WASTE DISCHARGE REQUIREMENTS FOR RANCHO SUPER CAR WASH Rancho Mirage - Riverside County

The California Regional Water Quality Control Board, Colorado River Basin Region, finds that:

- 1. Richard H. Fromme (hereinafter also referred to as the discharger), 71-490 Highway 111, Rancho Mirage, California, 92270, verified the below updated information on March 30, 1985 on the discharge of wastes.
- 2. The discharger is discharging a maximum average of 6,400 gallons-perday of washwater from a car wash. The wastewater is discharged into a sand trap from which some is reclaimed for irrigation of plants and the residual is disposed of in seepage pits located in the SW¹/₄ of the SE¹/₄ of Section 6, T5S, R5E, SBB&M. Domestic sewage from two (2) restrooms is discharged into a septic tank/seepage pit disposal system.
- 3. The discharger is reserving areas of sufficient size for possible future 100 percent replacement of the seepage pits.
- 4. The discharge has been subject to waste discharge requirements contained in Board Order No. 78-99.
- 5. There are no domestic wells within 200 feet of the discharge facilities described in Findings No. 2 and 3 (above).
- 6. The Water Quality Control Plan for the Colorado River Basin Region of California was adopted by the Regional Board on November 14, 1984. The Basin Plan contains water quality objectives for Coachella Hydrologic Subunit.
- 7. The beneficial uses of ground water of the Coachella Hydrologic Subunit are:
 - a. Municipal supply
 - b. Industrial supply
 - c. Agricultural supply

This car wash is located approximately 800 feet west of the nearest sewer line on San Jacinto Drive.

- 9. The Board has notified the discharger and interested agencies and persons of its intent to update waste discharge requirements for the discharge.
- 10. The Board in a public meeting heard and considered all comments pertaining to the discharge.
- 11. These waste discharge requirements govern an existing facility, which the discharger is currently operating, and therefore is exempt from the provisions of the California Environmental Quality Act in accordance with Section 15301 of Title 14, Chapter 3 of the California Administrative Code.

IT IS HEREBY ORDERED, the discharger shall comply with the following:

A. Discharge Specifications

- Neither the treatment nor the discharge of wastewater shall create a pollution or a nuisance as defined in Division 7 of the California Water Code.
- 2. No wastewater other than domestic sewage and car wash wastewater shall be discharged at this location.
- 3. Wastewater discharged subsurface shall be retained underground with no surfacing.
- 4. Adequate measures shall be taken to assure that flood or surface drainage waters do not erode or otherwise render portions of the discharge facilities inoperable.
- 5. Septic tank cleanings shall be discharged only by a duly authorized service.
- 6. There shall be no ponding of reclaimed wastewater used for irrigation, or surface flow away from the designated irrigation area.

B. Provisions

- 1. Sufficient land area shall be reserved for possible future 100 percent replacement of the seepage pits, until such time as this facility is connected to a municipal sewerage system.
- Upon request from this Board's Executive Officer, the discharger shall furnish technical and/or monitoring reports on the treatment and discharge of wastes.

- 3. Prior to any modifications of this facility would result in material change in the quality or quantity of wastewater discharged, or any material change in location of discharge, the discharger shall report in writing to the Regional Board.
- 4. Prior to any change of ownership of this car wash the discharger shall:
 - a. Specify as a condition of transfer that the area specified in Provision B.1 (above) remain servient to the facility for the purpose of providing additional subsurface sewage disposal capacity, until such time as this car wash is connected to a municipal sewerage system.
 - b. Transmit a copy of this Order to the succeeding owner or operator, and file a copy of the transmittal letter with this Board.
- 5. This Order supersedes Board Order No. 78-99.

2. Immediate reporting of any surfacing of wastewater or other failures of the system by telephone and follow-up by letter.


