ORDER NO. 85-78

**WASTE DISCHARGE REQUIREMENTS
FOR
LAKE CUYAMACA PUBLIC RECREATION AREA
Southeast of Julian - San Diego County**

The California Regional Water Quality Control Board, Colorado River Basin Region, finds that:

1. Lake Cuyamaca Recreation & Park District (hereinafter also referred to as the discharger), 15027 Highway 79, Julian, California, 92036, submitted updated information on the discharge of wastes on April 17, 1985.
2. The discharger is currently discharging a total maximum average of 2300 gallons-per-day of septic tank effluent from the following two locations:
 - (1) The South Shore facilities, which consist of a restaurant, two (2) campground restrooms, a recreational vehicle dump-station and a fish cleaning station; and
 - (2) The North Shore facilities, which have two (2) campground restrooms and a fish cleaning station.

Septic tank effluent from holding tanks at both locations is periodically pumped into a tanker truck and hauled approximately 6 miles to a land disposal site where it is uniformly spread over a remote and relatively flat grass-covered ridge. This area is occasionally grazed by horses and beef cattle. The disposal site is located in the SW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 23, T13S, R4E, SBB&M. All solids in the septic tanks are removed periodically and hauled to El Cajon for discharge into the community sewerage system.

3. This discharge has been subject to waste discharge requirements contained in Board Order No. 78-61.
4. The Water Quality Control Plan for the Colorado River Basin Region of California was adopted by the Regional Board on November 14, 1984. The Basin Plan contains water quality objectives for the Anza-Borrego Hydrologic Unit.
5. The beneficial uses of the groundwaters of the Anza-Borrego Hydrologic Unit are:
 - a. Municipal supply
 - b. Industrial supply
 - c. Agricultural supply
6. The Board has notified the discharger and interested agencies and persons of its intent to update waste discharge requirements for the discharge.

7. The Board in a public meeting heard and considered all comments pertaining to the discharge.
8. These waste discharge requirements govern existing facilities, which the discharger is currently operating, and therefore are exempt from the provisions of the California Environmental Quality Act in accordance with Section 15301 of Title 14, Chapter 3 of the California Administrative Code.

IT IS HEREBY ORDERED, the discharger shall comply with the following:


A. Discharge Specifications

1. Neither the treatment nor the discharge of wastewater shall create a pollution or a nuisance as defined in Division 7 of the California Water Code.
2. No wastewater other than that specified in Finding No. 2 (above) shall be discharged at the designated land disposal site.
3. There shall be no discharge of sewage solids at the disposal site.
4. There shall be no ponding of discharged septic tank effluent or surface flow away from the disposal area.

B. Provisions

1. Prior to any substantial change in the quality or quantity of wastes discharged or the location of discharge, the discharger shall report in writing to the Regional Board.
2. The discharger shall comply with "Monitoring and Reporting Program No. 85-78", and future revisions thereto, as specified by the Executive Officer.
3. In the event of any change in control or ownership of land or waste disposal facilities described herein, the discharger shall:
 - a. Notify this Board of such change; and
 - b. Transmit a copy of this Order to the succeeding owner or operator, and file a copy of the transmittal letter with this Board.
4. This Order supersedes Board Order No. 78-61.

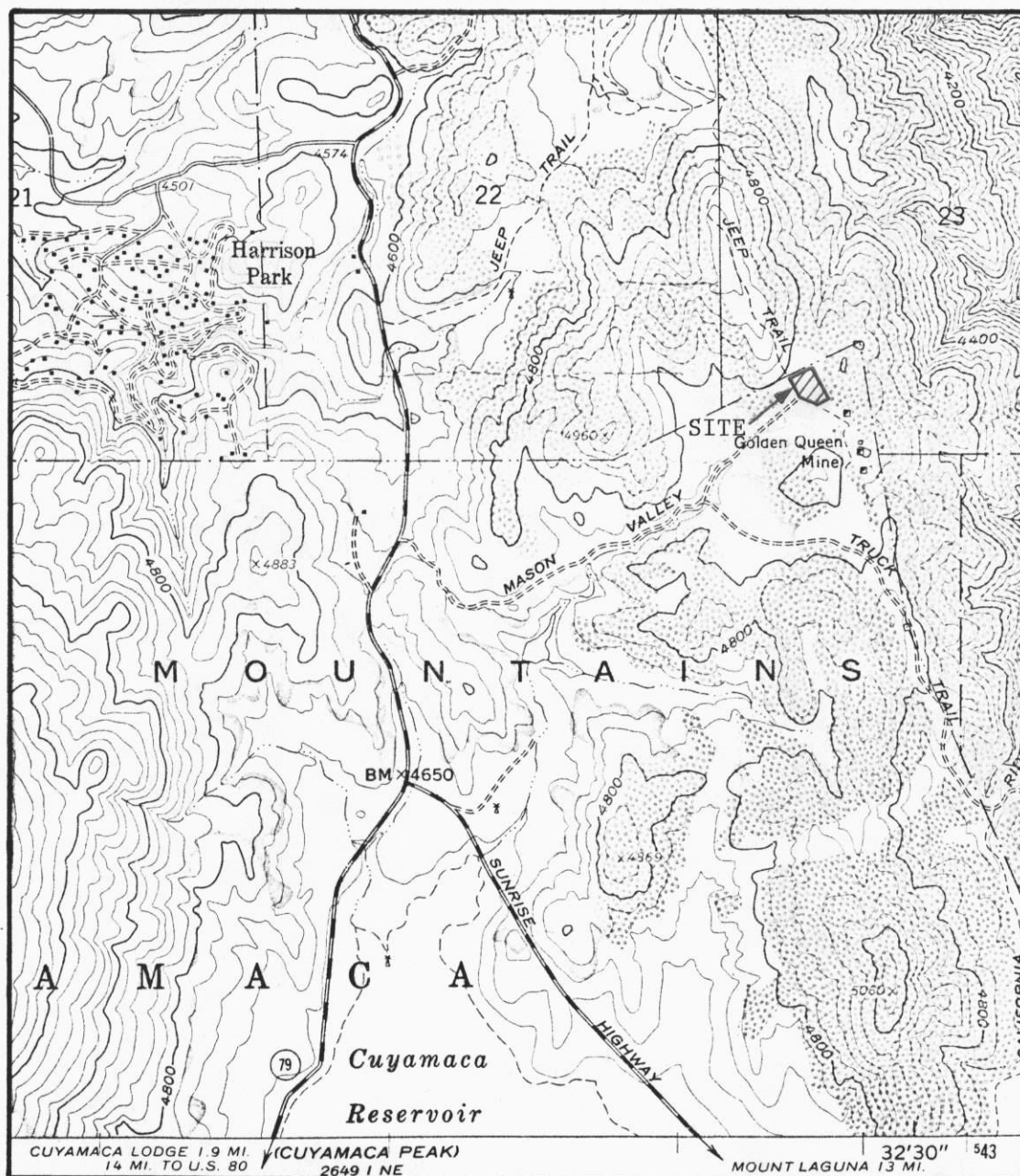
