### ISSUED TO ARICA SOLAR, LLC ARICA SOLAR PROJECT

The California Regional Water Quality Control Board, Colorado River Basin Region (Colorado River Basin Water Board) is releasing for public review and comment proposed Order R7-2022-0002 (Proposed Order) to Arica Solar, LLC for the Arica Solar Project (Project). Arica Solar, LLC is proposing to construct, operate, maintain, and decommission a solar energy production facility on 1,355 acres of land in Riverside County, approximately 5 miles east of Desert Center. The Project will be on land managed by the U.S. Bureau of Land Management. The Project is expected to impact waters of the state.

The Colorado River Basin Water Board intends to consider adopting the Proposed Order during a public hearing that will commence at the time and place indicated:
