The California Regional Water Quality Control Board, Colorado River Basin Region (Colorado River Basin Water Board) is releasing for public review and comment proposed Order R7-2022-0001 (Proposed Order) to the Victory Pass I, LLC (Permittee) for the Victory Pass Solar Project (Project). The Project is located on the Bureau of Land Management (BLM)-administered land in Riverside County, north of the I-10 and approximately 5 miles east of Desert Center, California. Access to the sites would be from Corn Springs exit off the I-10. The Project is expected to impact waters of the state.

The Colorado River Basin Water Board intends to consider adopting the Proposed Order during a public hearing that will commence at the time and place indicated:

Time: 9:00 a.m.  
Location: Virtual Meeting via Zoom Video and Teleconference

Based on the ongoing COVID-19 emergency, and in accordance with Government Code section 11133 (effective September 16, 2021), the meeting will occur solely via remote presence.

Interested persons are invited to attend and express their views orally on this matter at the public hearing. The Colorado River Basin Water Board requests that those persons wishing to speak at the hearing provide a copy of their oral comments in writing before or during the hearing to ensure accuracy of the record.
