MCCABE UNION SCHOOL DISTRICT WASTEWATER TREATMENT PLANT
FOR VIOLATIONS OF
BOARD ORDER NO. R7-2002-0001
NPDES PERMIT NO. CA0104281**

The McCabe Union School District owns a sewage collection system and wastewater treatment facility serving McCabe Union School District. On January 16, 2002, the Regional Water Quality Control Board adopted Waste Discharge Requirements Order No. R7-2003-0001 (NPDES Permit No. CA0104281), for the McCabe Union School District, to regulate discharges of waste from the Wastewater Treatment Plant, Collection and Disposal System.

On May 19, 2004, the Regional Board Executive Officer issued Administrative Civil Liability Complaint (ACLC) No. R7-2004-0092 proposing that McCabe Union School District pay \$15,000.00 in administrative civil liability for the violation(s), or implement the approved Compliance Project proposed on March 15, 2004.
