**NOTICE OF PUBLIC HEARING AND  
NOTICE OF FILING OF A DRAFT ENVIRONMENTAL DOCUMENT**

In the Matter of a Proposed Amendment  
To the Water Quality Control Plan for the Colorado River Basin Region

**NOTICE IS HEREBY GIVEN** that the California Regional Water Quality Control Board, Colorado River Basin Region (Regional Water Board) will hold a public hearing to receive comments on, and consider adoption of, a proposed amendment to the Water Quality Control Plan (Basin Plan) for the Colorado River Basin Region, and its supporting draft "substitute environmental document" prepared pursuant to section 21080.5 of the California Environmental Quality Act. The proposed amendment will establish a Conditional Prohibition and Implementation Plan for Agricultural Wastewater Discharges Originating within the Palo Verde Valley and the Palo Verde Mesa.

The draft substitute environmental document concludes that the proposed amendment will have no significant effects on the environment. The document also includes analyses of socioeconomic impacts, and reasonably foreseeable means of compliance with the proposed amendment. The technical justification for the proposed amendment is provided in a staff report.

At the conclusion of the public hearing, the Regional Water Board will consider approval of the draft substitute environmental document and adoption of the amendment as proposed, or as modified as a result of deliberations. Changes made to the amendment, if any, will be consistent with the purpose of the amendment.

The public review period for the proposed amendment, draft substitute environmental document, and staff report will be from July 1, 2010, to August 31, 2010.
