**NOTICE OF PUBLIC HEARING

WASTE DISCHARGE REQUIREMENTS R7-2011-0034**

The following discharger has requested Waste Discharge Requirements (WDRs) for a Groundwater Treatment Discharge Sprinkler System located adjacent to the Kinder Morgan Liquid Terminals LLC Fuels Terminal located at 345 West Aten Road Imperial, California 92251, Imperial County, an active fuel loading, storage, and transportation facility. The site encompasses approximately 30 acres with 27 aboveground storage tanks containing gasoline and diesel fuels.

Affected stakeholders and other interested persons are invited to attend and express their views on this matter at the public hearing. Those who wish to speak at the hearing will be asked to fill out a speaker request card and provide it to Regional Water Board staff. In order to have adequate time for the presentation by Regional Water Board staff, however, comments from the public will be limited to three (3) minutes per person. If the presentation may take longer, please let Regional Water Board staff know before speaking so that the presentation can be appropriately scheduled at the hearing. Where speakers can be grouped by affiliation or interest, such groups will be expected to select a spokesperson and not be repetitive. To ensure accuracy of the record, the Regional Water Board requests that any speakers who have prepared written statements for oral presentation at the hearing submit those statements to Regional Water Board staff before or during the hearing.
