TIME SCHEDULE ORDER (TSO) R7-2011-0051

IN THE MATTER OF
ST. ANTHONY FISH FARM, INC., OWNER
SERGIO CARRANZA, OPERATOR OF ST. ANTHONY TRAILER PARK
SEPTIC TANK/OXIDATION BASIN DISPOSAL FACILITY
South of Mecca – Riverside County

St. Anthony Fish Farm, Inc., 8617 Lake Ridge Circle, Las Vegas, Nevada 89117 owns the St. Anthony Trailer Park, and Sergio Carranza, operates the Park's Septic Tank/Oxidation Basin Disposal Facility (hereinafter Facility). The Discharger is discharging a maximum daily flow of 15,000 gallons-per-day (GPD) through five (5) septic tanks into five (5) unlined oxidation basins that have a design capacity of about 37,000 GPD. St. Anthony Fish Farm, Inc. and Sergio Carranza as the responsible parties for the Facility are herein after, individually or jointly, referred to as the Discharger.

On September 4, 2002, the Regional Board adopted Board Order R7-2002-0128, which specified prohibitions, specifications, and provisions necessary to protect the beneficial uses of the surface and ground waters within the Colorado River Basin Region.

On June 22, 2011, Regional Board staff inspected the Facility and found numerous violations of Board Order R7-2002-0128. On June 24, 2011, the Assistant Executive Officer issued a Notice of Non-Compliance (NON) to the Operator requesting the Operator to correct the problems by July 7, 2011. The Discharger failed to respond to the request. Accordingly, pursuant to California Water Code Sections 13300, tentative TSO R7-2011-0051 is proposed to be issued by the Regional Water Board to order the Discharger to be in full compliance with Board Order R7-2002-0128 by October 31, 2011.

Persons wishing to file written comments on, or objections to, the tentative TSO are requested to do so within 30 days of the date of this Notice so that the Regional Board may consider the comments. Comments must be mailed to the following address:
