**NOTICE IS HEREBY GIVEN THAT** the Regional Water Quality Control Board – Colorado River Basin Region (Colorado River Basin Water Board) will accept written comments on the proposed underground storage tank (UST) cases closure for the Blythe Environmental Remediation Project Commingled Plume 4 including Site A, B, C, and D. Regional Board (RB) Case Nos. 7T2 225 022, 7T2 225 148, 7T2 225 147, and 7T2 225 149. These Underground Storage Tank (UST) sites are being proposed for cases closure pursuant to the State Water Resource Control Board's "Water Quality Control Policy for Low-Threat Underground Storage Tank Case Closure," which became effective on August 17, 2012 (Policy). In adopting this Policy, the State Water Board determined that certain UST cases are appropriate for closure if they pose a low threat to human health, safety, and the environment. Low threat may be demonstrated under the Policy by showing that the UST cases meet the general and media-specific criteria established in the Policy, the case closure requirements satisfy Health and Safety Code Section 25296.10, and cases closure are consistent with State Water Board Resolution 92-49's requirement that cleanup goals and objectives be met within a reasonable time frame.

Enclosed is a draft Policy review summary prepared by the Colorado River Basin Water Board for the above-entitled matter. Pursuant to the Policy, the Colorado River Basin Water Board will be providing notice about these proposed cases closure and the draft Policy review summary to municipal and county water districts, water replenishment districts, special act districts with groundwater management authority, agencies with authority to issue building permits for land affected by the petroleum release, owners and occupants of the property impacted by the petroleum release, and the owners and occupants of all parcels adjacent to the impacted property, as applicable. This Notice and the Policy review summary will also be posted on the Colorado River Basin Water Board's Public Notice web site.
