## NOTICE OF PUBLIC WORKSHOP

The California Regional Water Quality Control Board, Colorado River Basin Region (Regional Water Board) will hold a Public Workshop on February 19, 2015, to discuss the development of a Salt and Nutrient Management Plan for the Coachella Valley (hereafter referred to as "CV-SNMP"). Salt and Nutrient Management Plans (SNMPs) are an outgrowth of the State Recycled Water Policy adopted in 2009. It is the intent of the policy to manage salts and nutrients from all sources on a basin-wide or watershed-wide basis in a manner that ensures attainment of water quality objectives and protection of beneficial uses. The State Water Resources Control Board (State Water Board) sees SNMPs as the best mechanism to manage salts and nutrients in this way as opposed to imposing requirements on individual projects. SNMPs are to be developed by local water and wastewater entities, together with local salt/nutrient contributing stakeholders. The water and wastewater entities fund collaborative processes that are locally driven and controlled and are open to all stakeholders, including participation by Regional Water Board staff.

Four stakeholder meetings have been conducted to date. Stakeholders have provided comments on two technical memoranda prepared for the CV-SNMP. These memoranda have been presented at the stakeholder meetings, and posted for review and comment by the CV-SNMP Technical Group. These include:

- Technical Memorandum No.1, "Preliminary Data Review and Documentation of Technical Methods," and
- Technical Memorandum No. 2, "Ambient Water Quality."

## The goals of the workshop are:

- To provide background for the Regional Water Board members on the State Recycled Water Policy and an update on the development of the SNMP for the Coachella Valley;
- 2. To allow Regional Water Board staff to discuss at greater depth the objectives, requirements, and other relevant aspects of SNMP development pursuant to the State Recycled Water Policy (for example, requirements for monitoring and scientific peer review);

- 3. To provide State Water Board staff an opportunity to update stakeholders and other interested persons on the status of SNMP development statewide;
- 4. To provide an opportunity for affected stakeholders to discuss with Regional Water Board members issues and concerns regarding the methodologies proposed in Technical Memoranda Nos.1 and 2 for developing an SNMP for the Coachella Valley; and
- 5. To provide sufficient information to enable the Regional Water Board to provide direction to its staff.
