Staff of the California Regional Water Quality Control Board, Colorado River Basin Region (Colorado River Basin Water Board), prepared Waste Discharge Requirements, Board Order R7-2015-0018 for the City of Needles Wastewater Treatment Plant, located at 516 East Broadway, Needles, CA 92363, for the disposal of treated domestic wastewater from the wastewater treatment plant to an evaporation/percolation pond system.
