The following discharger has submitted a Report of Waste Discharge for the below-named facility:

Staff of the California Regional Water Quality Control Board, Colorado River Basin Region (Colorado River Basin Water Board), prepared tentative Waste Discharge Requirements, Board Order R7-2015-0043, for the above Discharger for the disposal of tertiary treated domestic wastewater for groundwater recharge. The Discharger proposes to construct a wastewater treatment system and groundwater spreading pond recharge system. The Colorado River Basin Water Board will hold a public hearing on the proposed Waste Discharge Requirements during its regular Board meeting, which is scheduled as follows:
